Special Education Needs and Disability (SEND) Information you will need for the school's website.

You should update any changes occurring during the year as soon as possible. The report must comply with section 69 of the Children and Families Act 2014, meaning that it must contain:

the 'SEN information' specified in schedule 1 to the <u>Special Educational Needs and Disability Regulations 2014</u>. Statutory guidance on this is contained in paragraphs 6.79 to 6.82 of the <u>special educational needs and disability code of practice: 0 to 25 years</u>

information on:

- the arrangements for the admission of disabled pupils
- the steps you have taken to prevent disabled pupils from being treated less favourably than other pupils
- the facilities you provide to help disabled pupils to access the school
- the plan prepared under paragraph 3 of schedule 10 to the Equality Act 2010 (accessibility plan) for:
 - o increasing the extent to which disabled pupils can participate in the school's curriculum
 - improving the physical environment of the school for the purpose of increasing the extent to which disabled pupils are able to take advantage of education and benefits, facilities or services provided or offered by the school
 - improving the delivery to disabled pupils of information which is readily accessible to pupils who are not disabled
